- 4. That the school shall equip the science Lab. as per the norms of the Department and suitable facilities for practical work shall be provided to the students. More material worth Rs.5,000/- shall be provided to the students. More material worth as to the Education purchased during 1997-98 and a list to be furnished to the Education Officer for verification.
- 5. That a proper library shall be stablished and facilities for reading from shall also be made available for students as well as teachers. More approved standard books shall be purchased. Books as per the ratios of 10 books per student may be added and facilities of reading from my also be provided immediately and more books worth of reading from also be provided immediately and the list Rs. 5,000/- be purchased by the start of next session and the list of books are furnished to E.O. for verification.
- 6. That the adequate sports material shall be purchased for out door, games and indoor games during the session 1997-98.
- 7. That the school shall strictly abide by the provisions of Delhi School Education Act and Rules, 1973 and payment shall be made as per section 10(I) of Delhi School Education Act, 1973 to all the employees through crossed cheque and proof should be shown to concerned E.O.
- 8. That the enrolment in each section shall not exceed the number of students calculated @ 10 sq.ft. per student for the available of students calculated @ 10 sq.ft. per student for the adequate for area of the class from and the school shall provide adequate sufficient accommodation as per the terms and of the department sufficient accommodation acc

- 10. That the school shall not run any unrecognised classes or any other activities within the school premises and all the recognised classes shall be run at one place. No branch of this school shall be run under the banner of the recognised school.
- 11. That the school shall dsipemse with the services of unqualified and ever aged staff, if any immediately.
- 12. That all the facilities prescribed under Rules 50 & 51 of the DSER, 1973 shall be made available to the students, provision of Rules 6, 7 and 9 be strictly observed.
- 13. That the service contract betweeen the management and the employees shall be executed immediately.
- 14. That the arrangement of good drinking water shall be made available to all the students as well as to the teachers and sanitary facilities shall also be provided to the students, adequately.
- 15. That the violation of any instructions/orders/conditions/rules and regulations of the department shall lead to the withdrawl of recognition of the school and class, shall not be opened without the prior approval of the Director of Education, Delhi.
- 16. That the management of the school shall create a Reserve Fund equal to three months salary of the staff in a joint name of the Director of Education and the Manager of the School in any scheduled bank within a month.
- 17. That the school/society shall apply for the allotment of land and will construct the building as per specification of Dte. of Edn., Delhi within a period of three years.
- 18. That the Management of the school shall provide all the facilities as per rule 5 and all conditions as required under rule-51 shall be complied with.
- 19. That a report about the fulfilment of the above conditions giving the extent to which each conditions is fulfilled shall be sent to the Education Officer every six months.
